AMENDMENT NO. 4 TO CONTRACT

Contract No. <u>2020-52</u>

THIS AGREEMENT, dated as of _______, 2021, by and between the CITY OF YONKERS, having offices at CITY HALL, 40 SOUTH BROADWAY, YONKERS, NEW YORK 10701 (the "City) and Mark Fang, a consultant, having offices at One Penn Plaza Suite 3687, New York, New York 10119, hereinafter referred to as the "Contractor".

WITNESSETH:

WHEREAS, under an agreement dated as of May 16, 2019 between the City and the Contractor (the "Contract") the City has engaged the Contractor to assume the role of Director of the Commission on Human Rights in the City of Yonkers, New York; and

WHEREAS, said Board of Contract and Supply of the City originally approved the Contract on April 18, 2019; and

WHEREAS, the parties entered into a first amendment to extend the contract through June 30, 2021; and WHEREAS, the parties entered into a second amendment to extend the contract through June 30, 2022; and WHEREAS, the parties entered into a third amendment to extend the contract through June 30, 2023; and WHEREAS, the parties hereby wish to further amend the Contract pursuant to this Amendment to Contract by extending the term for an 12 months and increasing the aggregate.

NOW, THEREFORE, the parties agree as follows:

- The term of the Contract shall be extended 12 months for the period July 1, 2025 through Julie 50, 2024 4. unless terminated by a written notification signed by the Mayor of the City of Yonkers.
- Should any terms or conditions within the Contract and this Amendment potentially conflict, conflict or 3. be inconsistent with one another, the Amendment shall control. If there are multiple Amendments, the Amendments shall govern in chronological order, for example, with the most recent Amendment governing over all others.
- Except as specifically modified or amended by the terms of this Amendment No. $\underline{3}$, the Contract shall 4. remain and continue, in full force and effect, and is hereby, as amended, ratified, adopted, restated and confirmed.
- This Agreement shall become effective on (a) the date set forth at the head of this Agreement, provided 5. that this Agreement shall have been executed by and between both parties hereto; or (b) the date by which the City shall have obtained the approval of this Agreement by the Board of Contract and Supply of the City, whichever of (a), or (b) shall last occur.
